Dear W.C.,

I am writing to see if you can help my sister-in-law. Her husband left her two years ago with her son who is six years old and autistic. We have not seen him since he left, and he rarely sends any child support. She came down with Covid and was hospitalized for the past three weeks.

My husband and I have been taking care of her son as we have no other family that can help. She is really struggling now that she has been off work and works paycheck to paycheck. I help her out when I can, but my husband and I caught Covid from our nephew who came here with only the sniffles, so we were off work for two weeks each, with no pay. My sister-in-law has just been released from the hospital and is so weak she is staying with us to allow her to regain some strength. She is so stressed about her bills that I worry she is hampering her recovery. I truly wish we could do more than make her meals and watch our nephew, but even that is stretching our budget. We do not have enough room in our one bedroom condo for them to move in fulltime. This is becoming stressful for all of us. I thought of The Time is Now to Help and hoped you could help.

Dear Readers,

We know so many people who are sick or recovering from Covid right now. It is a trying time for sure as we had all hoped and prayed this virus and the additional pains of illness and poverty it causes would be behind us.

I called the woman to see how we could help. I asked her what she knew about our charity work, and she shared that she had read our column several times and looked us up on the internet. I did not need to explain to her how we worked together to provide poverty relief. I could tell she had done her homework.

I asked about her sister-inlaw and how she was doing after a few more days of recovery. She said the sister-in-law was still living with them due to her continued weakness and inability to care for not only her son but herself as well. She was too weak to even prepare meals or do laundry, so she continued to sleep with her son on their couch.

I spoke with the weak sisterin-law for a few minutes and listened as she still struggled to speak for even that short time. I asked if she would be able to go over her budget and she asked if I could do that with her sister-in-law. When the woman returned to the phone, we went through the outstanding bills that were causing the woman so much stress.

Together we provided rent for the sister-in-law, car payments and a utility payment to prevent her from falling further behind. We also provided grocery gift cards for when she returned home and for her to help with

Legislature fails again

he clock is ticking before the next election and we as a state have failed again to take action — putting us again in position to have last-minute election drama.

Going into an election with multiple races, all candidates and races should be subject to the same rules. Those rules should be clear. And election officials shouldn't have to worry about the rules changing at the last minute.

That is not the case.

The spring primary is about four weeks away on Feb. 15, followed by the April 5 spring

This is not a presidential election year and statewide

general elections are not until November. But the April elections are just as important, with residents deciding who runs cities, counties and school districts. Here in Lake Geneva, we have a mayoral primary. Now more than ever those races are so important.

Yet there is still uncertainty going into the elections, on issues like voter drop boxes and how clerks can correct absentee ballots missing a witness' full address.

There are too many last minute changes.

For instance, on Wednesday, Jan. 12, the Wisconsin Election Commission's website stated it's up to each municipality if they want to use ballot absentee ballot drop boxes.

"The use of secure absentee ballot drop boxes is an accepted Both were to be prepared for elections practice in the United States that far predates the 2020 elections cycle ... Until the courts or legislature address mary. this matter that remains a local decision," the Wisconsin Election Commission (WEC) states on its website.

Then, on Thursday, Jan. 13, a Waukesha County judge ruled that the drop boxes cannot be

As for how to fix an absentee ballot with missing witness information there is also ambiguity.


When the Wisconsin Election Commission met in December they directed staff to prepare drafts with guidance, one that mirrors current guidance and

a best alternative proposal. the March 9, 2022 commission meeting, which is about a month after the February pri-

On top of that, the Joint Committee for Review of Administrative Rules, of which Sen. Steve Nass, R-Whitewater is the co-chairman, voted on Monday, Jan. 10, to require the WEC to submit emergency rules within 30 days or cease issuing directives on ballot drop boxes and guidance on correction of errors and omissions on absentee ballots.

And if the WEC does make rules, Nass has warned that his committee has the power

End Nass' war on **COVID** pandemic responses

Since the pandemic began Sen. Steve Nass (R-Whitewater) has used his co-chairmanship and partisan advantage of the Joint Committee for Review of Administrative Rules (JCRAR) to halt or limit efforts by Gov. Evers, Wisconsin Department of Health, UW System and now the Wisconsin Election Commission to protect Wisconsinites from the ravages of COVID-19. After the Republican-controlled Legislature refused Evers's call for "special legislative actions," the governor issued executive orders for protective measures to be taken. Nass insisted that the governor's actions required JCRAR approval, even during a worldwide health pandemic. Nass used the JCRAR to limit the effectiveness of these protective directives.

The Wisconsin Department of Health issued preventive actions to safeguard Wisconsinites from COVID. Nass once again demanded these actions, even during a health emergency be brought before his committee. Nass became the self imposed czar of any efforts to safeguard Wisconsin claiming that government pandemic responses were an attack on individual freedoms.

UW President Tommy Thompson issued emergency COVID directives across the state university system. Sen. Nass ordered Thompson to submit his directives for JCRAR approval despite only 14% of the UW System budget comes from state funds. Thompson informed Nass that UW had the authority to take nimble and reasonable steps to

keep campuses open and safe. Thompson reminded Nass that the health and safety of the students, faculty and staff during a global pandemic were Thompson's responsibility, not the JCRAR.

Recently Nass announced that the Wisconsin Election Commission's emergency guidance to utilize vote drop boxes, allow nursing home residents to vote without special voting deputies present [nursing homes were closed to all visitors due to the pandemic] and allow election clerks to correct clerical omissions on absentee ballot envelopes failed to gain JCRAR approval. Nass directed the WEC to submit to his committee's au-

Sen. Nass insists that even short term emergency directives used in a crisis must gain his JCRAR approval. During a worldwide health pandemic we do not need a Wisconsin legislative committee reeking havoc on state agencies as they battle to keep Wisconsinites safe and alive. The appropriateness of a handful of partisan legislators invoking roadblocks to commonsense governing during crisis situations needs to be examined as this ongoing pandemic continues.

Vouchers are only denied because of a lack of funds or previous abuse of the system. Very accurate records of who receives vouchers and who has abused their use are on file. Vouchers are never made out to an individual. They are made out to the establishment involved. If the Walworth County total is down this year, Madeline will run out of funds in 2022.

After having been coordinator of Walworth area bell-ringing for over 15 years, it is time for me to step down. This is a plea for a new team of people to step forward and take over this most worthwhile cause. 
