

Three districts prepare for Sept. 1 start date

Open houses start today

The end of summer is approaching and parents and students in the Northland Pines, Three Lakes and Phelps school districts are preparing to head back to school for the 2022-'23 school year beginning Sept. 1.

Ahead of the first day, districts will host open houses where parents and students can visit the classrooms, meet teachers and drop off supplies.

Starting today, Wednesday, Aug. 24, Northland Pines will hold open houses at all of its schools across the district, main, Eagle River and Land O' Lakes, from noon to 7 p.m.

Appointments at elementary schools are required, and appointments for middle- and high-schoolers are recommended for students going into grades seven or nine, or those who are new to the district this year. All other students are welcome to drop in.

A second open house opportunity for Northland Pines Elementary schools will be held Monday, Aug. 29, from 9 a.m. to 5 p.m.

District Administrator Scott Foster stated that Northland Pines so far has welcomed nine new, certified staff members to the district, and five paraprofessionals.

"In addition to this group we had some staff join us mid-year, last year and we

including those in St. Ger- are excited for them to start with us at the beginning of the school year," he said. "We have also hired multiple custodians to add to our team. In addition we have multiple transfers between positions as well."

> While the pandemic is winding down, Northland Pines has put forth some protocols for people who may become sick this year.

Foster said if a student or staff tests positive for Covid, they will complete a 10-day quarantine or isolate in the home for five days and return to school and all other activities on days six through 10 with a well-fitted mask that covers the mouth and nose.

Symptomatic students and staff should stay home, but may return to school as long as they have been fever-free for 24 hours without the use

of fever-reducing medication and their symptoms are resolving, or if a medical professional makes an alternative diagnosis.

A negative test is recommended but not required for returning to school.

"We will not have a testing site this year, but we have signed up to get free at-home test kits that we can provide to families and staff," Foster said. "We will let families know if their child was around a positive case, however parents may opt out of getting these messages."

Besides coming back after day five of a positive test, it is the students' and staffs' choice to mask — there is no requirement from the district. "As we have always done,

Three Lakes school firmly approves referendum vote

The Three Lakes School Board unanimously approved authorization for the district budget to exceed its revenue limits by \$4.25 million per year for the next five years, starting with the 2023-'24 school year for non-recurring purposes.

Board members subse-

in establishing the amount of the referendum.

Despite this referendum showing a 37% increase over the previous referendum, it is the second smallest percentage increase in referendum funding requests for non-recurring purposes dating back to the 2006 district referendum.

The board noted that due

quently unanimously approved setting up a referendum election for the district's electorate on Nov. 8 to vote on the referendum.

The school district is currently entering its final year of the previous five-year referendum which was initiated for the 2018-'19 school year.

In making its decision, the district considered staff salaries, health insurance costs, property valuations, transportation costs, utility increases and enrollment predictions

to property valuations within the school district increasing over the past two years, the mil rate for this proposed referendum will be slightly less than the mil rate for the previous referendum, averaging \$5.11 per \$1,000 equalized valuation over five years, compared to a yearly average of \$5.71 per \$1,000 equalized valuation for the 2017 referendum.

Scheduling issues continue to plague **ERRA**, Falcons

Owners of the Wisconsin Windigo juniors hockey team had announced last week it was ready to adjust some game times slightly in hopes of helping to sew the divide between themselves, the Eagle River Recreation Association (ERRA) and the Eagle River Falcons and the Great Lakes Hockey League (GLHL).

It appears though the GLHL won't budge as league commissioner Pete Krueger said moving games times up an hour or so to allow for two games on the same night just isn't feasible.

"That's not going to fly

because I'm not going have my teams, like Fond du Lac, come up there to start a game at nine o'clock at night, not get done until midnight, and then drive home," Krueger said. "(The Windigo) did volunteer to move one game back during Pond Hockey, but the Falcons would still have to play the late game Friday night.'

While it had first appeared last week there was some positive movement on issues arising from the contract between the ERRA and the Windigo, that optimism now seems
