Governor vetoed a different repeal bill in July

Democratic Gov. Tony Evers announced a plan with Democratic lawmakers late last week to repeal the personal property tax, even though in July he vetoed different legislation proposed by Republicans to get rid of the tax.

Republicans called Evers's latest action political posturing, but Evers said the bill was an improvement over the one he vetoed.

The personal property tax is primarily levied on business equipment that is not included in real property. The governor said the tax was outdated and that his repeal would create new state aid to compensate local government for their lost revenue.

"When I ran for gover-

nor, I promised I would cut taxes for middle-class families, and I'm proud to have kept that promise by delivering one of the largest tax cuts in state history in my most recent budget, on top of the \$480 million in tax relief for Wisconsin businesses and families affected by Covid-19 that I signed into law earlier this year," Evers said. "This legislation will continue our efforts to

support businesses and families as they bounce back from the pandemic while ensuring our local governments have the aid they need to remain whole.

According to Evers, the Republican bill he vetoed was drafted "haphazardly," creating what he called problematic ramifications for railroad taxes and the
