'God will be with us as we heal'

Hundreds gather at vigil for those killed and injured in parade tragedy

WAUKESHA — Amid the coldest temperatures of the season thus far, there were tears, hugs and the overwhelming illumination of candlelight as the sun dipped beneath the sky.

Hundreds of mourners and supporters huddled together at Cutler Park on Monday to commemorate the five people killed and the nearly 50 others injured when a man drove through the Waukesha Christmas Parade on Sunday.

Local officials and members of the faith community spoke to the crowd before the candle-lighting vigil that was augmented with a somber instrumental rendition of "Amazing Grace." The names of the people killed in the parade also were read

Police identify five who died after man drove through crowds at Waukesha Christmas parade

WAUKESHA — The five victims who died after a man drove through crowds at the Waukesha Christmas parade at 4:39 p.m. Sunday have been identified.

The names are Virginia Sorenson, 79, LeAnna Owen, 71, Tamara Durand, 52, Jane Kulich, 52, and Wilhelm Hospel, 81.

Waukesha Police Chief Dan Thompson announced the names of the five killed during a press conference at 1 p.m. Monday. An additional 48 victims are injured, a number which may increase as more information is gathered, he said.

Waukesha parade suspect allegedly ran over victim in previous incident

Milwaukee County DA: Conducting 'internal review' over bail decision

WAUKESHA — The Milwaukee County District Attorney's Office announced they are conducting an "internal review" of the bail decision for a prior case involving the suspect who allegedly drove through crowds at the Waukesha Christmas parade on Sunday, resulting in five fatalities.

The suspect has been identified as Darrell Brooks, 39, from Milwaukee.

In a previous case from earlier this month, Brooks allegedly ran over a victim with his vehicle, according to a criminal complaint.

Vigil

Tragedy is a familiar concept to Pardeep Singh Kaleka, executive director of the Interfaith Conference of Greater Milwaukee. Kaleka, who spoke at Monday's vigil, lost his father nearly a decade ago at the Sikh temple shooting in Oak Creek.

"Tonight, we are blessed to be surrounded by our sacred faith families and amazing faith readers who stand united to support each of us in the richness of their religions and spiritualities," Kaleka said.

The Rev. Kris Androsky of the Brookfield-Elm Grove Interfaith Network also was on hand.

"We come to you, seeking peace where there seems to be no peace and healing where there only seems to be brokenness," Androsky said in her prayer. "Tonight, we seek peace and healing with you for our children, for every family and household impacted by this tragedy, for our service providers, for our leaders.

The human desire to try making sense out of a senseless event was a theme interwoven throughout the vigil. But a number of speakers, including Waukesha Fire Chief Steve Howard, said the acts of heroism were on prominent display in the immediate aftermath

"As I talked with people, as I observed first responders and community members last night and throughout the day today, we do have a lot to be thankful for,' Howard said. "I'm very thankful for the people that stepped up and set aside their family to treat the

Waukesha Police Chief Dan Thompson echoed similar sentiments. "Yesterday's tragic event demonstrated the character of this community," Thompson said. "When tragedy struck this great city, the community

While an incident as horrific as this can provoke challenging faith questions, Deacon Mike Finley of St. Vincent de Paul's Waukesha location said he believed God was present in the face of it.

"Despite all the tragedy, we saw evidence of good, of people — not even knowing what was going on — they rushed in to help," Finley said. "God will be with us as we heal — and, unfortunately, the toughest part, perhaps, of this healing process will be forgiveness.'

Looking to the future, Finley said he believes Waukesha will move forward in the difficult road ahead because of its resiliency and strong sense of commu-

"I hope and I pray that God will be with us next year at the 2022 Waukesha Christmas parade where we can all celebrate again as a community," Finley said.

Hospitals continue treating patients after tragedy

Patients brought to multiple area hospitals

— Chil-WAUKESHA dren's Hospital of Wisconsin was still performing surgeries on injured children Monday after the mass casualty event at the Christmas parade in Waukesha Sunday, officials said in a press conference Monday morning.

Children's Wisconsin Emergency Department and Trauma Center medical director Dr. Amy Drendel said law enforcement notified Children's shortly after the event and she initiated the hospital's trauma surge plan to call in nurses, doctors, surgeons and other employees to help care for the children.

Drendel said the first patient was brought to Children's Hospital at 5:30 p.m. and that 18 total were brought in for emergency care — ranging in age from 3 years old to 16 years old, including three sets of sib-

She said the last mass trauma patient to be admitted

was around 9:30 p.m. while involved and staff. medical professionals worked well into the night treating children.

Drendel said the injuries sustained included facial abrasions, broken bones and "serious" head injuries.

Six of the patients were sent to the operating room Sunday night, Drendel said, while two more were undergoing surgery on Monday.

In total, 18 children were admitted into Children's Hospital as a result of the tragedy including 10 into the intensive care unit. As of the press conference Monday morning, of the 10 patients in the ICU, six patients were in critical condition, three were in serious condition and one was in fair condition in the intensive care unit. The remaining eight patients were in fair condition not in the ICU.

Two children have been discharged.

Children's Wisconsin Pediatric Intensive Care Unit medical director Dr. Michael Meyer said mental health support has been activated for families, the children

'Social work, mental health teams and our chaplain teams are all actively rounding the intensive care unit as well as the other units in the hospital," Meyer said. "It is amazing to watch them work as a single team to help our families and children.

ProHealth Care Strategic Communications Director Susan Rasmussen said 29 people were seen at Waukesha Memorial Hospital. Twelve people were seen in their emergency department and released along with 11 children being assessed and transferred to Children's, Rasmussen said.

Furthermore, four people, adults and children, were admitted to Waukesha Memorial and were in stable condition on Monday, Rasmussen said.

Additionally, according to a statement from Advocate Aurora Health Public Affairs Manager Cheri Mantz, Aurora Medical Center-Summit treated 13 patients from Sunday's tragedy. Three of the 13 patients remain at the hospital with two in critical condition and one in serious con-

'Our hearts go out to all who have been impacted by this tragedy," Mantz said.

Children's Wisconsin Chief Medical Officer Dr. Michael Gutzeit said Children's has appreciation and gratitude for the first responders and other hospitals that provided "tremendous support and excellent stabilization of patients.

We all must continue to lean on each other and to encourage those impacted to reach out and use the resources available to them,' Gutzeit said.

Safety changes sweep region after Waukesha tragedy

Menomonee Falls cancels parade

WAUKESHA — Area municipalities are updating their safety precautions for their holiday events and parades in the wake of the mass casualty event that took place at the Waukesha Christmas parade Sunday night.

Menomonee Falls

Menomonee Falls has decided to cancel its parade scheduled for this weekend because of the tragedy in Waukesha, an alert said on the village website.

On his Facebook page, Menomonee Falls Village President Dave Glasgow said although he has every confidence in the police department to take the appropriate actions to ensure a safe parade, the desire to stand with the people of Waukesha is weighing heavily on the hearts of those in the village.

"In Waukesha County the community parades share some of the same participants," Glasgow said in his post. "One group in particular lost several of their dear members who were planning to be in our parade this weekend. We also realize that some of our residents may be apprehensive about attending with this hitting so close to home. And there were Falls residents in Waukesha yesterday who witnessed firsthand this horrific, senseless event.'

Glasgow said he had seen some talk of saying the decision was made out of fear and he wanted to let residents know that was not the

"No fear was involved in this decision," he said. "It's a demonstration of compassion, empathy and respect for the Waukesha community, victims and families.'

Glasgow said the decision was not an easy one to make.

"But we believe under the circumstances it is the right one to make," Glasgow said in his post. "I'm reminded time and time again that Christmas, among other things, is an opportunity for healing, to give up one's self and selfinterests, to think of others, and to put their needs before ours.

West Bend

In West Bend, the police department sent out a press release announcing that there will be additional precautions for the city's Christmas parade.

West Bend Police Department Oconomowoc met today (Monday) to review and discuss security and logistics for the West Bend Christmas Parade scheduled for Sunday, Nov. 28 at 5 p.m," reads the release. "In order to ensure all participants and spectators are safe, we will be putting additional security measures in place for Sunday's parade in West Bend."

Participants and spectators attending the parade may not be able to park in spots they did in the past as additional road closures will be in place. Highway 33 at 7th Avenue will be closed to through traffic during the parade. There are detour routes marked on Highway 33 eastbound at North 18th Avenue and on Highway 33 westbound on Indiana Avenue. Drivers not attending the parade should follow the detour signs as police will have the road closed at 7th Avenue until the end of the parade. No vehicles will be allowed to cross 7th Avenue.

Parade organizers and West Bend police are asking spectators to allow more time to get to the parade, and to be cooperative with police and volunteers that are staffing the intersections and parade route.

With the Oconomowoc German Christmas Market kicking off Wednesday and its holiday parade happening on Dec. 4, city officials including Western Lakes Fire Chief Brad Bowen, Oconomowoc Police Chief Jim Pfister and Mayor Bob Magnus met today to discuss the safety plan.

Newly-named City Administrator Mark Frye said in an email to Conley Media Monday that a press release will be sent out by noon today to outline the plan the city has in place.

'As a group we will expand this process to include all the wonderful events that are held in the City throughout the year but prioritized these two due to when they are scheduled to occur," Frye said in the email.

State Rep. Barbara Dittrich, R-Oconomowoc, said she was in contact with Bowen, who told her additional safety plans and security measures are in place.

The safety of our celebrants is of the utmost importance." Dittrich said in her release.

Grafton

In Grafton, the Grafton Chamber of Commerce is working to determine how/if to move forward with the 41st annual Grafton Christmas parade scheduled for Saturday.

"The safety of all our parade participants, volunteers and specis our utmost importance

ty list," according to a statement from the chamber on Facebook. 'We want to ensure a safe community gathering."

Pam King, executive director of the Grafton Chamber of Commerce, said she met with the Grafton Police Department and village officials Monday morning and they have developed a plan "that is focused on the safety and security of our participants and spectators."

"We have always had a very strong police presence at our parade, but we will definitely be adding many new precautionary measures," King said.

Police Chief Jeff Caponera issued a letter to the community Monday afternoon.

"Obviously we want to be respectful of the victims, their families and the Waukesha community," he said. "At the same time, we believe that we cannot allow this tragedy to drive us into fear and keep us from celebrating the holiday season - there has been enough fear-mongering as of late and we don't need anything to divide us.

Caponera there will be a final decision at 3 p.m. today on whether to continue the parade.

"We appreciate your patience as we navigate this unfortunate situation," he said. "Rest assured, should the parade continue as planned, we are confident that our measures will result in and are all at the top of our priori-safe and enjoyable event for all."

Archdiocese members injured, CMH students reflect on experience

WAUKESHA — Classes were not held at Catholic Memorial High School Monday, but students, parents and members of the community flowed into its halls all the same. They gathered for a Mass scheduled after a man drove an SUV into the Waukesha Christmas Parade on Sunday, killing at least five and injuring at least four

the parade. They were not among those injured, but only narrowly avoided the SUV.

Rory Fox and Morgan McKnight, both CMH seniors, were in the parade. Each apparently helped the other avoid serious injury or worse Sunday. McKnight said he didn't hear the vehicle approaching but when Fox turned around so did he — he then pushed Fox out of the way and got grazed by the vehicle himself but only sustained a scratch and bruises.

Multiple students said they felt the truck driven by art teacher Daniel Burau in the parade shielded them from harm.

"It was really instant," said Braydon Cooper, another CMH senior, of when he realized something was wrong. "At first I was kind of in shock... it was completely

He said people began clearing objects from the road to make a clear path for ambu-

CMH students took part in lances, his mother Angela Jerome Listecki encouraged Cooper was with him and when he saw bodies "I did have one freakout moment because I didn't know where she was.'

Angela Cooper said the group they were with took refuge at Realty Executives. They eventually sheltered at a nearby church until they were able to return to their vehicles.

"It was pretty horrible," CMH senior Cassie Smith said of her own experience Sunday. "I'm just happy everybody I know was OK, but my heart goes out to everybody that was affected because I know I won't forget

Attendees Monday embraced each other tearfully before the service began.

Rogers trauma recovery director offers guidance after Christmas parade tragedy

Provides advice to community on how to process events, speak with children

WAUKESHA — The clinical director of trauma recovery services at Rogers Behavioral Health based in Oconomowoc is providing insight to the Waukesha community on how to process the traumatic events that unfolded downtown on Sun-

Chad Wetterneck, Ph.D., said community members are likely experiencing a range of emotions, and that's normal. It likely doesn't look the same for everyone — some may be in a state of shock, where they are not feeling much of anything. Others may be experiencing emotions where they are shaken or crying when they think about the event, he said.

We are going to feel differently and potentially strongly about something like this, especially happening so close to where we live or if you were there — that's normal to feel," he said. "So let's make sure that we're not looking at this like 'Is there something wrong with me?' If I couldn't sleep or sleep well, if I'm thinking about it a lot, if I'm replaying it in my

Wetterneck said it's also common for individuals at such events to feel survivors' guilt. Wetterneck said some people may also be reminded of other traumatic experiences in their lives, so it's best not to share videos of the incident with others, whether you were there or not.

"You can't un-watch something ... you can decide for yourself whether or not you can decide psychologically if you're in a place to see something like that," he said.

Children

Wetterneck said parents need to consider what they want to say to their children and plan how they want to communicate those things — even if it means writing down bullet points or practicing some of the conversation aloud to themselves.

"There's never a real right time and place to have conversations, but there's definitely some times and places that are less functional to do them," he said.

Wetterneck suggested avoiding times when distractions are around, such as if kids are in the middle of playing video games, and opting to instead talk about the traumatic incident in a quiet place such as during a walk.

"Make sure you ask them 'What do you know?' about what happened," he said. "They might hear something that's incorrect or they might already know more than you think they know, but I think it's really important to find out what they know that's factual.'

It's important to share with children the facts of what happened, so they are not operating on an inaccurate narrative, Wetterneck said. If adults don't know what happened, that's a decent answer, and they can look into it and provide more information later, Wetterneck said.

"This is scary enough as it is, so let's not make it scarier by making up things that are not true," he said.

Wetterneck said it's also important to reassure kids that they will be OK no matter what happens in the future.

Adults

Wetterneck said much of the advice he has for adults also applies to kids.

"You need to identify people that you feel like you can trust and are caring that you can talk about it with," he said.

Reaching out to friends and family is important, he said letting them know you're available to talk to them if they need to talk about it. Establishing a pattern of checking in with loved ones is also important, which makes it easier when it's needed the most.

Wetterneck said everyone also wants to know what happened, as new information is provided frequently. He suggests people maintain balance with other things they need to do in their life, and many should recognize when they need a break from it.

"It might be too early to talk about needing a break from this but I do know that some people are probably searching all news sources and refreshing screens, or whatever else, trying to find out (more) information in real time," he said. "All of that information does become available (even) if you space it out hours or even a day.'

Regular self-care activities are important as well, Wetterneck said — including eating, sleeping and relaxing activities before bed.

Being helpful and proactive also can assist community members through the process, including volunteering at events, getting involved with local agencies and making community donations.

Recognizing that you or someone you love may need professional help is also important.

"I would encourage people to consider whether or not they want to seek out professional help," he said. "(If you are looking for professional help) I would specifically look for people that say they specialize in working in trauma."



According to a criminal complaint, Brooks allegedly was involved in an incident with a victim with whom he shares a child in Milwaukee at a hotel. He allegedly "ran (the victim) over" after following the victim to a gas station and striking the victim in the face with a closed fist, according to the complaint. Officers allegedly observed the victim in this instance had tire tracks on her left pants leg.

Prior to that, on July 28, 2020, two counts of 2nd-degree recklessly endangering safety - use of a dangerous weapon and possession of a firearm - convicted as a felon were filed, also in Milwaukee County. In this instance, Brooks allegedly was involved in a physical altercation with a family member, according to the complaint. Brooks allegedly fired a shot at the family member when they were trying to drive away.

According to a statement issued by Chisholm's office, in the 2020 case, cash bail was originally set at \$10,000 and subsequently reduced to \$7,500. The demand by Brooks for a speedy jury trial could not be met and the case was adjourned and his bail was reduced to \$500, which Brooks posted on Feb. 21, 2021.

After the charges were filed on Nov. 5 in the 2021 case, a cash bail request of \$1,000 was set by the court. Brooks posted his bail on Nov. 11 and he was released from custody.

The state's bail recommendation in this case was inappropriately low in light of the nature of the recent charges and the pending charges against Mr. Brooks," the statement said. "The bail recommendation in this case is not consistent with the approach of the Milwaukee County District Attorney's Office toward matters involving violent crime, nor was it consistent with the risk assessment of the defendant prior to setting of bail. The office is currently conducting an internal review of the decision to make the recent bail recommendation in this matter in order to determine the appropriate next steps.

One of the victims brought to Waukesha Memorial Hospital was pronounced dead on arrival.

"The hospital is just blocks away from the parade route, and victims started arriving very quickly after the incident, in fact many of Pro-Health Care's staff were attending the parade, witnessed this tragedy and provided immediate first aid to the victims," Johnson said.

Thompson said prior to the incident, the suspect, Darrell Brooks, 39, from Milwaukee, was allegedly involved in a domestic incident at another location. Thompson said upon the police department's arrival to the scene of the domestic disturbance, Brooks was already gone. The department did not have the chance to respond to the domestic disturbance due to the alleged action of Brooks at the parade immediately after.

At this time, the Waukesha Police Department announced they are referring five counts of 1st-degree intentional homicide to the District Attorney's office with additional charges to come.

A firearm was discharged by an officer at the suspect with the intention of stopping the suspect, Thompson said. Due to the amount of people, that officer stopped and did not fire any additional shots. That officer is on administrative leave as a part of department protocol and no one was injured as a result of the officer shooting his weapon, according to Thompson.

Police Capt. Dan Baumann said the parade route started at the intersection of North Hartwell Avenue and East Main Street. The vehicle traveled down Main Street where crowds were walking in the parade. The area the vehicle took off from was near Veterans Park, traveling to the area of Wisconsin and Maple avenues.

Thompson said Brooks allegedly drove right through the barricades, although officers attempted to stop him. Thompson said it is uncertain what Brooks' intent was and if Brooks knew anyone walking in the parade.

A MABAS box alarm for mutual aid was issued immediately after the incident, according to Waukesha Fire Chief Steven Howard. The department received resources from 12 area fire departments. They were also d greatly by off-duty fire fighters and EMS personnel, medical personnel and civilians, Howard said.

Emergency response was further complicated due to power outages in the city related to strong winds at the parade on Sunday.

Brooks is expected in court at 4 p.m. today, according to a statement from Waukesha County District Attorney Susan Opper's office. At that time, criminal charges are also expected to be filed.

'Evil is real;' witnesses share stories at scene

After the suspect drove through the crowds, panicked people were heard calling for family members — a man was shouting a girl's name from the historic courthouse building's steps.

Multiple Waukesha South High School Band members were struck by the vehicle on West Main Street. Instruments were also seen scattered on the street, among victims.

Dance Team members were struck too.

"I was right there, I saw bodies flying," said Wauke-sha School Board member Corey Montiho. "I ran down the parade route to find my girls. Addison, my daughter, heard someone yell 'car' and ran away. The girls right next to her were hit. I was there. It was little kids and families...evil is real, fight it every chance you get.

Minutes after the incident, David Monfre told The Freeman he saw a red vehicle "come barreling through" Main Street.

"My son just passed with his band, which is Waukesha South, and a truck (came) barreling through, almost hit the back of a float truck... he ended up hitting a bunch of band members and it went all the way up the road.'

Monfre was collecting some of the instruments for South, he said. He said he got in contact with his son, who wasn't one of the ones that got hit, but almost was.





panicked calls to family. Inside Martha Merrell's, Tyson Apfelbeck said he saw the suspect "literally just running people (over) and swerving pretty erratically." He estimated the vehicle to have been traveling at about 20 miles per hour.

On Facebook, the Milwaukee Dancing Grannies said they were among the groups with deaths and injuries in the parade. "Those who died

were extremely passionate Grannies," the group posted. Their eyes gleamed... joy of being a Grannie. They were the glue... held us together."

The group said as more information and updates become available, they'll be posted. "Please keep them, their families, friends, the Milwaukee Dancing Grannies and everyone (whose) lives have forever changed in your thoughts and prayers," they said.

Citizens Bank announced one of their team members who was walking along with their parade float was one of the deceased in a statement Monday.

Immediate community response

Thompson said many community members quickly got involved and saved

School District of Waukesha schools will be closed for the rest of this week and reopen Monday.

Waukesha students were among those injured Sunday. As of 2:30 p.m. Monday, there were no confirmed deaths of students, staff or others directly affiliated with the district.

Deputy Superintendent Joe Koch said there's "no definitive information at this time" on the status of those injured, but it's known there are students who were injured to varying degrees.

Koch said the district is preparing for a return to classes Monday and is aware students and staff will have "varying needs on that day... people will grieve and process this at varying rates." The district will have supportive services for students and staff available for the foreseeable future to aid in the healing process going forward, he said.
