Punzel resigns from Minocqua Police Department

Officer had been under investigation and on paid administrative leave

Minocqua police officer Kaleb Punzel, who has been under paid suspension while the police department conducted an investigation into his conduct, has resigned.

His last day was May 4.

Punzel said he was resigning to explore "other personal opportunities" after three years with the department. He requested that his accrued leave of PTO (paid time off), holiday, and compensatory time be paid in

full

Punzel was placed on paid administrative leave pending the outcome of an investigation into conduct stemming from an incident in the summer of 2020, in which the officer brushed aside repeated pleas for help by a man who had been calling 911 to report that a female acquaintance could be in immediate danger.

The suspension came after *The Lakeland Times* published the first in a series of investiga-

Pilot program for combating elder abuse comes to Vilas County

After Vilas County was one of six counties in the state chosen to participate in an antielder abuse pilot program, through the Wisconsin Department of Justice and UW-Green Bay, its adult protective services (APS) department is now holding training sessions for first responders on how to recognize the signs of caregiver abuse and neglect, as well as self-neglect, in older adults.

"It's the first time in the 32 years I've been here at adult protective services that we were able to be part of a pilot project," APS social worker Donna Rosner said. "Our elderly demographics are high, close to 40 percent."

The program consists of a 2-hour training session, with a curriculum created by UW-Green Bay, designed to equip first responders to recognize and report suspected elder abuse when they are out on calls. The goal is for the training to eventually be offered in all 72 Wisconsin counties

During the session,

first responders will receive information about physical, sexual, emotional and financial mistreatment, and the warning signs of such abuse and neglect such as unclean physical and living conditions, passive behavior or a domineering caregiver, injuries or physical/chemical restraint, and unusual or extreme changes with respect to finance.

"We stress that we don't expect you to know, backwards and forwards, everything

Oneida County judge to retire this summer

Oneida County circuit judge Patrick O'Melia will retire effective Aug. 1, he announced in a May 4 letter to Oneida County Human Resources Director/Administrative Coordinator Lisa Charbarneau.

"After serving Oneida County for 18 years as the District Attorney and then serving Oneida County for 15 years as Judge for Branch I, as well as Deputy Chief Judge of the 9th Judicial District . . . I have come to the difficult decision to resign effective August 1, 2022," O'Melia wrote. "I have known many people who retired over the years. They would usually say, 'I won't miss the work, but I will miss the people who I worked with.' Like most clichés, truer words were never spoken. On the day-to-day basis, I will miss all of you, but I do intend to offer services as a Reserve Judge, so I am sure our paths will cross.'

The news of O'Melia's forthcoming retirement leaves a judicial vacancy that Gov. Tony Evers will need to fill.

As of this writing, the governor's office had yet to send out a request for applications to fill the seat.

O'Melia's term is due to expire in

Oneida County has long had two judgeships.

In 2007, O'Melia was appointed to succeed former Oneida County Circuit Judge Robert E. Kinney who had resigned the Branch I judgeship.

He was elected to the position in 2008 and has won re-election ever since.

Circuit judge Mike Bloom, who is also a former district attorney, has presided in Branch II since 2012, succeeding circuit judge Mark A. Mangerson.

The O'Melia family has been a fixture in the local legal community for over a century.

O'Melia's grandfather, A.J., founded the O'Melia, Schiek & McEldowney law firm in 1911. His father and uncle practiced at the firm and his brother, John F. O'Melia, is a partner.

about elder abuse (in order to make a report)," Rosner said. "If you suspect it, call us."

Elder abuse investigations can include APS home visits and interviews, as well as reviews of medical and financial records. They may result in offers of voluntary care services, emergency actions for protective placement and services, or referrals to law enforcement and regulatory agencies.

"We've already gotten a couple calls already, since the training started, from EMS," Rosner

So far, the training has already been conducted three times in Vilas County, with the fourth to take place May 11, from 6 to 8 p.m. at the Phelps Community Center. Participants will earn two hours of continuing education units (CEUs) for completing it.

tory articles about the incident. In the incident, Punzel arrested the man for drunken driving — that was dismissed but he was convicted of reckless driving-endangering safety — but refused to head to a nearby residence where the man said his acquaintance was being held and was in danger.

Neither did Punzel relay any sense of urgency to other responding officers or in his communications with police dispatch, records obtained in an open records request showed.

The woman that the 911 caller was worried about subsequently said she was sexually assaulted during the time Punzel was dismissing the seriousness of the threat, and filed a notice of claim against the town of Minocqua, the Minocqua Police Department, Punzel, and the man she alleged to have assaulted her.

It took police more than 90 minutes after the man's first 911 call for police to arrive at
