Police officer dies of COVID complications

FOND DU LAC - A 26-year-old Fond du Lac police officer died from complications of COVID-19 the day after his second child was born, the police chief

With apple crops light, here's what to expect at The Little Farmer

MALONE - This fall's visitors to The Little Farmer, N9438 U.S. 151, can expect a few changes in the availability of apple products due to a crop and labor shortage.

A late spring freeze affected apple orchards across the state, and fewer apples this season means The Little Farmer will need to prioritize their products, according to The Little Farmer LLC Facebook page.

Bakery items and caramel apples will get top priority, but there will be fewer opportunities to get apple cider. "U-pick" apples will be unavailable this year, but fresh apples are available prepicked in the shop. Freshly pressed apple cider is expected weekly, but the

For many theater-goers, the inside of a dark auditorium, surrounded by hundreds of people, is an escape from the world. It's a time dedicated to disregarding all that lies beyond the theater walls and, instead, surrendering to drama, comedy, music, tragedy and romance.

With theater performances reemerging in Wisconsin and across the country during yet another COVID-19 surge – a plot twist even some in the industry didn't foresee - that escape is once again turned on its head.

in-person performances With planned, the delta variant raging and people itching to get back out in public, the burden of keeping audiences, staff and artists safe is falling on those in charge of venues.

"No one trained me how to keep people safe during a pandemic," said Joe Ferlo, who's been the president and CEO of the Grand theater in Oshkosh for 10 years, and was director for 15 years before that. "We're just a group of people who have to make the best decision we can make."

comfort to Joseph's family. Joseph will be missed by everyone here.'

The statement did not say how Kurer was believed to have contracted COVID-19 but called it a "line of duty death." The chief did not disclose whether Kurer was vaccinated and provided no further information about his death.

Kurer was a member of the department's Tactical Field Force Team, Honor Guard Unit and Domestic Violence Intervention Team, and earlier this year was certified as a field training officer. He also was an Aviation Operations noncommissioned officer achieving the rank of sergeant in the Wisconsin Army National Guard, according to Goldstein.

Kurer was awarded a Fond du Lac Police Department Life Saving Award, Army Commendation Medal, Army Achievement Medal and Air Force Sergeants Association NCO of the Year as a cadet noncommissioned officer in the Civil Air Patrol. He also received a Sister Michaela O'Brien Award while attending St. Mary's Springs Academy in Fond du Lac.

A law enforcement procession escorted his body from a hospital early Thursday to the funeral home, and officers will stand vigil by his side until the services are complete, Goldstein said.

Kurer is survived by his wife and two children, one born the night before he died. He is also survived by his parents and sister.

Gov. Tony Evers and his wife, Kathy, on Thursday issued a statement extending their sympathies. The governor also signed an executive order to lower the U.S. and Wisconsin flags to honor Kurer when funeral arrangements have been made.

"Our hearts go out to his wife, kids, parents, and sister, and all of his loved ones, especially as they had just welcomed a new baby to the family the night before Officer Kurer's passing," the Evers' statement said. "We are also thinking of the Fond du Lac Police Department and the Fond du Lac community, and we ask the people of Wisconsin to join us in extending offers of support and prayers as they mourn Officer Kurer's

On Thursday, police officers in Fond du Lac deco-

rated Kurer's police squad with a wreath, and parked it in front of the department at 126 N. Main St.

Funeral arrangements with law enforcement honors are pending.

An official GoFundMe page has been set up for donations to benefit his children. As of Thursday evening the page had raised more than \$6,100.

Roy was born on December 23, 1946, in Wisconsin Rapids, the son of the late Elroy and Magdalene (nee Flick) Voigt. He graduated from Campbellsport High School in 1965. Following high school graduation, he enlisted in the United States Air Force and was stationed in Dover, Delaware. During his four years in the military, he visited 32 countries and served in the Vietnam War. After the Air Force, he moved to West Bend and worked at Gehl Company.
