City will pay \$37,834 to attorney who resigned after alleged gun incident

The former Sun Prairie city attorney currently facing charges of bringing a loaded gun into a bar was paid over \$9,000 while on leave and will receive \$37,834 in wages after he resigned last month.

Mark A. Leonard, 61, is charged with operating firearms while intoxicated, carrying a handgun into a place where alcohol is sold and consumed, and disorderly conduct in connection with a June 10, 2021 incident at Ripp's Bar in Waunakee. The court case is pending.



paid leave from his city attorney position on June 11. The city council accepted Leonard's resignation on Sept.

Leonard was placed on

10. Leonard received \$9,211 for 21 days of paid leave between June 11 and Aug. 27, 2021. Leonard used paid time (vacation and sick) for the remaining days, city human resources director Brenda Sukenik reported. The Sun Prairie Star obtained the information

through two separate open records requests from the City of Sun Prairie.

Leonard will be paid \$37,834 through the end of the year and will be covered under city health insurance until Dec. 31, 2021.

City records show Leonard's wages for 2021 are \$115,730 and \$24,638 in benefits.

The city appointed Matthew Dregne as the interim city attorney on July 6. Dregne's billing rate as interim city attorney is \$225 per hour.

Leonard was hired as the city attorney in September 2013. City Administrator Aaron Oppenheimer described Leonard as a

dedicated and loyal employee in according to the criminal coma letter written after Leonard's resignation.

Leonard is scheduled for an Oct. 29 pre-trial conference in Dane County Circuit Court.

On June 10, patrons at Ripp's Bar reported that Leonard appeared to be intoxicated and was showing handguns to other customers.

Waunakee Police made contact with Leonard at Ripp's Bar and removed a Glock 34 and a Glock 43, from Leonard's hip holster and his waistband, along with a full 9mm magazine on the top of the bar where Leonard reportedly was sitting,

plaint.

A bartender at Ripp's Bar told Leonard that he could not have guns at that bar but that she was afraid to call police because she feared for her safety, according to the criminal complaint. The bartender said she did not see Leonard point the guns at anyone. A bar patron called 911, according to the criminal complaint.

Leonard's preliminary breath alcohol test was 0.17 -twice the legal limit for Wisconsin motorists, according to the criminal complaint.

Alders not ready to let public back to in-person meetings

Alders concerned about the spike in delta variant COVID-19 cases and their safety won't let the public back to in-person city hall meetings.

Alders have been meeting in person since July but public access has been restricted to virtual since spring 2019 when the pandemic began. And it's not clear when the public will be welcomed back as city alders made no change last month on public access. Although the public has the option to attend meetings virtually, the Wisconsin Open meetings law state, "It is declared to be the policy of this

state that the public is entitled to the fullest and most complete information regarding the affairs of government as is compatible with the conduct of governmental business. To that end, the law requires that,"All meeting of all state and local governmental bodies shall be publicly held in places reasonably accessible to members of the public and shall be open to all citizens at all times unless



otherwise expressly provided by law."

Last month, some city alders said if people are allowed back into city hall for meetings, they will attend virtually. An idea to allow a limited number of people to attend meetings also

Stonewood Crossing fire displaces 10 people

A fire Thursday night, Sept. 30, displaced 10 people on Stonewood Crossing in the City of Sun Prairie.

According to Asst. Fire Chief Bill Sullivan, Sun Prairie Fire & Rescue (SPFR) responded to the 1100 block of Stonewood Crossing in the City of Sun Prairie for a multi-fam-

garages. Immediately, a box alarm was requested for additional units from neighboring communities while Engine 3 began putting water on the fire from the truck mounted deluge nozzle

Sullivan said SPFR Engine 3 connected to a fire hydrant in front of the building and used a hose line to complete fire extinguishment.

Sun Prairie Engine 1 connected to the fire hydrant on the corner, and searched the units to confirm everyone was out of the building. City of
