### Old body shop hits the road

#### Business sold to son as Conrad Durski retires

Early bird risers on Highway 70 West in Eagle River were treated to a rare sight recently as they passed a two-bay commercial garage slowly making its way down the road.

The structure, owned by 70 West Auto Body, was sold to friends of the Durski family and relocated to make way for 70West's planned new office, spray booth and drive-up estimating facility, slated for a Dec. 9 completion.

The expansion at 70 West Body Shop comes at a historic turning point for the growing familyrun enterprise, as Sayner resident Conrad Durski prepares to sell the business to his son, Chris, and daughter-in-law, Melissa, as he eases into a well-deserved retirement.

A North Woods resident since 1979 and a 55year veteran of the auto body business, Conrad got his professional start as an 18-year-old working at General Motors' Fisher Body plant in Milwaukee for four years before transitioning to body shop work at a variety of car dealerships and, eventually, taking the entrepreneurial plunge with his March 1999 purchase of 70 West Auto Body established in 1981.


"Every day is different," Conrad said of his enduring passion for the auto body business.

A few years after purchasing 70 West Auto Body, Conrad was joined by Chris. The father-andson duo have worked sideby-side for the past 22 vears.

But those days are drawing to a close for Conrad as his retirement nears with the impensing sale of the business to a

second Durski generation. "Chris has been with me since a couple of years after I got the place and we've been working together and expanding the business ever since," Conrad said. "It's a good change and good move for him."

For his part, Chris is looking to build upon the foundation built by his father.

**New facility** Building on that legacy is 70 West Auto Body's planned new facility, which necessitated removal of the firm's original shop building at 822

W. Pine St., Eagle River. Chris is excited about the new, expanded 3,456square-foot office and shop facility that will soon begin rising on the old shop's site, saying the new building will offer the firm much needed additional office space, aesthetic "curb appeal" along namesake Highway 70, an additional paint booth, and a first-ever drive-up estimating facility.

But for Chris, there's also a bit of nostalgia for the original shop, recalling fond memories of working alongside his dad, sharing a passion for

all things auto body. "It's kind of an emotional thing," Chris said. "We used to work out of there. That's how we started. It's kind of hard to see it go."

On the move

Faced with the need to remove 70 West Auto

Body's old shop facility, Chris decided to sell and relocate the building, rather than raze it.

With sharply-rising lumber costs this year, Chris said recycling and repurposing the company's original shop facility made good sense.

"You hate to see it just become a pile of rubble, especially with the way that prices are," he said. "People should start selling and moving their buildings rather than knocking them down. I think it's neat that we're not just going to wreck it all, that we're able to do this. Maybe it'll get people's minds twirling — Hey, maybe I can do

Tapped for the moving job was Merrill-based Schuette Movers, founded in 1946, which relocates some 30 to 40 structures a year as Wisconsin's oldest and largest structural moving company.

"You can move any structure as long as you can get it there and the roads are wide enough," said Lance Peterson, partowner of Schuette Movers.

On Sept. 21-22, Schuette crews lifted 70

West Auto Body's original 32- by 44-foot shop building off its foundation and placed it on a 53-foot spread axle trailer for

The move, a "typical job" according to Peterson, was made on Sept. 23 at 4

"The state dictates when we can go and can't go," Peterson said. "They determine it because we're going on state high-

Not surprisingly, there are a number of considerations to be made in transporting a building from one location to an-

"You've got to figure out your routes and your loaded heights and wires," Peterson said. "You've got to get around utility poles. Once you get on site, you've got to be wide enough to get in there and have enough room to maneuver around. There's a lot that goes into it."

Two Vilas County Sheriff's Office deputies provided escort for Schuette Movers on the 3-mile, 40minute move west on Highway 70 and south on Highway 17 to the building's new home at the town of Lincoln residence of David and Shirin Eliason, 628 Highway 17 South.

"Everything went off without a hitch," said David Eliason, an Eagle River Realtor, of the early morning move.

#### 'Win-win' deal

In need of a primary garage for their residence, the Eliasons paid Chris Duski \$10,000 for the old 70 West Auto Body' facility and "just under \$10,000" to Schuette for the move.

After paying private contractors for a concrete foundation, new overhead garage doors and interior finishing work, David Eliason estimated the total cost will come in at around \$65,000 — a tidy sum but still a sizeable cost savings versus an estimated \$75,000 to \$80,000 for new construction in today's inflated market.

"I'm a real estate guy and Chris is a friend, and I've done business with him before," Eliason said. "He said he was moving the place and asked me if we were interested in buying it and moving it. We had a need for a garage and decided we could make sense of it.

"It was good for him obviously . . . and it was good for me, because at the end of the day I'll save a little bit of money relative to building a brand-new one. In the vein of being in the real estate business and doing deals, we figured it was a pretty good win-win for both Chris and for me, so that's why we did the deal. Win-win deals that's the kind of deals we like to put together," Eliason said.
