# Tapping into area beer gardens

### Outdoor brew spots sprout during the summer

ather with friends in the garden and Genjoy a beer or two this summer.

Beer gardens are a popular tradition in southeast Wisconsin and there are many places to enjoy them, from sites with an official German feel to casual pop-up locations.

In Germantown, Von Rothenburg Bier Stube has been in operation for around 30 years, according to Chaz Hastings, who coowns the business with Scott Carleton.

Hastings said the location is "probably the most authentic German beer garden" in the area. It features 14 German beers on tap, a German food menu as well as traditional decor at the Main Street location.

"It's beautifully landscaped," said Hastings, adding that the location opens daily at 11 a.m. and there is live music on Friday and Saturday nights as well as Sunday after-

"In Germany, the beer garden (owners) are very prideful and take it seriously. We've been over there a number of times to do some market research," Hastings said. The staff at Von Rothenburg Bier Stube

wear some traditional clothing and music is piped in from German radio stations, according to Hastings.

"You literally feel like you're in Germany,"

Domestically, Von Rothenburg is one of the biggest pourers of Benediktiner Weissbrau, brewed at a monastery in Germany, according to Hastings.

'And I think we're in the top three as far as Weihenstephan," he said, noting it is one of the oldest breweries in the world having started in 1040.

The location also serves beers by Andeker, Paulaner, Hacker-Pschorr, Krombacher, among others, Hastings said.

Clientele at Von Rothenburg come to the Germantown location from around southeast Wisconsin, according to Hastings, who said in the winter the location features the beer stube (room) inside.

On the menu, he recommended trying the doner kebab, which he said is particularly popular with customers after Oktoberfest.

"It's an incredible sandwich," Hastings

The menu lists the doner kebab as including beef and lamp, lettuce, tomato, cucumber and red onions and topped with tzatziki and doner sauce and served on naan bread. Other beer garden operators bring brews

to rotating locations. Pop-Up Beer Gardens by Raised Grain Brewing Company will be held on scheduled

Fridays and Saturdays in the Waukesh County Parks throughout the summer, according to the Raised Grain website.

The brewery will serve a lineup of eight beers and the gluten-removed Diamond Hard Seltzer in a variety of flavors, the site said.

"Local food trucks, including Tramper's Oak Fired Pizza, will also be at the beer gardens," the site said.

The Waukesha County Park System is also partnering with The Tap Yard to offer beer gardens in Fox Brook Park, Menomonee Park and Minooka Park, according to the county website.

#### Beer garden on the go

A beer garden on the move can be found in The Beergo, operating inside a converted 1984 Winnebago, which has been around for about six years, according to owner Mike Awve.

He purchased it three years ago.

"It's a mobile beer garden. We can drive it anywhere and set up shop," he said, noting The Beergo features eight tap lines with craft beers from Wisconsin brewers.

"We also sell hard seltzer in cans and soda and juice," Awve said.

The Beergo, which is billed online as "The World's Greatest baR-V," recently underwent a complete engine rebuild, according to

"It might be an '84 on the outside. It's not an '84 on the inside," he said.

The Beergo can be found every Thursday at the the Pewaukee Ski Show, according to Awve, who said the mobile beer garden makes pit stops throughout the Lake Country region at both public and private events.

It features beers from area breweries, typically MobCraft and Broken Bat, Awve said.

# Sliding into the heat of summer

## Amusement parks glisten with games, slides, rides and more

rom rides to water slides, area amusement parks offer ways to find entertainment this summer.

At Springs Water Park at The Ingleside Hotel in Pewaukee, there are a variety of features for families to try, according to Kiara Herrea, graphic designer and marketing associate.

The water park is 45,000 square feet, including both water and nonwater attractions, according to the park website.

The park includes three large water slides, Herrea said.

The slides are the Cyclone, a 206foot body slide, Double Trouble, a 317-foot-long tube slide for one or two people, and Triple Dog Dare, a 362-foot boat slide for up to three people, the website said.

In addition, there are smaller slides and a zero-depth entry water park area for smaller children, according to Herrea.

"It's perfect for the little ones," she said, adding that the park includes squirting cannons and a 600-gallon dump bucket that dumps about every 10 minutes.

The larger slides are for individuals 48 inches and taller.

"The older ones love those," said Herrea, who said Springs Water Park is currently open daily for summer hours.

The hotel offers a variety of packages for visitors, including various amenities, like arcade credits, according to Herrea.

During holiday peak periods when traffic is heavier, Herrea recommended booking in advance.

"We do have some special offers," she said.

The hotel and water park draw visitors from a wide range, according to Herrea.

"We see people from all over. Locally from Waukesha and Milwaukee, and also the suburbs of Chicago and Minnesota. We've seen people drive and fly in from lots of places," she said.

"It has something for the whole family," she said of the hotel and water park combination.

"Our outdoor whirlpool is adult only," she said. "There's something for adults, kids, preteens and teenagers. The water park also offers day

passes via its website, according to Herrea.

#### Fun in Fondy

Those up for a trip can visit two amusement parks in Fond du Lac, the Fondy Sports Park and Fondy Aqua Park.

The former was established in the early 1980s by a group of teachers from Waupun, according to Bob Deuster, one of the current park

A day pass may be purchased online and is \$25 Mondays to Wednesdays, \$30 on Thursdays, \$40 on Fridays and Sundays, and \$50 on Saturdays, holidays and peak periods. Children 23 months and younger get in free.

"We took it over in 1999," said Deuster, who said there are four owner-operators of the two parks, which are run separately.

"All of us had been in the family fun center business," he said, of

the current ownership team. The aqua park, about 100 yards

from the sports park, is now in its eighth season, Deuster said. He said it includes water slides, a zip line, water course, water craft

and more. 'We saw something similar to what we're doing in the Wisconsin Dells area," said Deuster, of the origination of the idea for the local

He said the Fond du Lac aqua park "started small."

'We didn't know how well this was going to work in the Fond du Lac area," he said, adding it has

grown in the years since. "Every year we've had it in all eight years we've added to it," Deuster said.

Those 6 years old and vounger are restricted to the shallow section; a sand bottom with 3 feet or less of water.

"Life jackets are required for deeper areas," said Deuster, who said jackets are included with admission or visitors may bring their own.

The sports park has also been expanded, including the go-kart track and the addition of a new batting cage system, according to

He said the parks do offer vending machines but visitors are encouraged to plan for a picnic.

"The aqua park is a perfect picnic-type setting. There's two huge oak trees, shade and grassy area,' said Deuster, who said several area pizza restaurants do deliver to the

The two parks experienced an expanded radius of interest during the pandemic, according to Deuster.

'We were open and people started driving and the circle of influence became two to three hours. People came from Illinois and places we hadn't seen before," he said, noting social media helped grow the reach of the parks.

While the parks are run separately, there is one crossover all-day pass available.

"You get a wrist band for both and can go back and forth. More and more people are doing that as people are coming from farther away," Deuster said.

The sports park opens earlier and closes later than the aqua park, according to Deuster, who said tickets are sold at the gate.

"We've never had a problem where we sold out," he said. The sports park season is typical-

ly the start of April through mid-October, depending on the weather, according to Deuster.

The aqua park is typically open Memorial Day through Labor Day, he said, noting that two of the four owners are on the property at all times.

Overall, he said the parks are accessible for those in the Milwau-

"It's an easy drive up the (Interstate) 41 corridor," he said.

## Winter weather or not

### Cross-country skiing statewide and what local trails need to open up

or cross-country skiing enthusiasts, the past few weeks haven't offered much in terms of the necessary temps and precipitation needed to partake in the sport in southeast Wisconsin.

So for those determined to hit the trails, travel may be involved.

'While some parts of the state are experiencing an unseasonable lack of snow, other areas are a winter wonderland," said Craig Trost, Travel Wisconsin's communications director.

He said the season still offers a "wonderful time to make shared moments of joy with friends and families.'

Travel Wisconsin runs an online snow report showing which crosscountry trails are open.

"The report is an interactive map detailing the conditions at skiing and snowboarding hills, crosscountry skiing trails and snowmobiling networks throughout the state," Trost said.

The report is the most popular resource on TravelWisconsin.com, but Trost said this year has been a standout in use of the online tool.

This winter "has seen a huge increase in early season traffic," he said, adding that residents in southeast Wisconsin do have options for a cross-country skiing getaway.

"The Wisconsin State Park System, for example, has hundreds of miles of trails spread across nearly four dozen properties," Trost

He recommended that those hoping to ski right now check out the Northern Highland-American Legion State Forest, calling it a "standout destination."

"It's our largest state forest, spanning Vilas, Oneida and Iron counties. The forest has more than 110 miles of groomed and ungroomed cross-country trails," Trost said.

#### Snow made at Lapham

Currently, Lapham Peak Unit of the Kettle Moraine State Forest is the only trail in southeast Wisconsin open for cross-country skiing, according to Travel Wisconsin.

The trail has both snow makers and lights, according to Emily Heller, public communications coordinator for the Waukesha County Parks & Land Use.

She said while the park trails are typically busy, there is enough space to accommodate those who are interested in skiing or enjoying the park, even while it is the only local trail offering skiing at the moment.

As of Wednesday, the man-made loop for skiing at Lapham Peak Unit was still open with a base of snow in place, according to the Travel Wisconsin snow report.

Grooming elsewhere at Lapham Peak has been postponed and conditions were icy on Wednesday, the report said.

Heller suggested checking the schedule online before heading out to the park.

"They do host some races so people might have to double-check schedules," she said.

What kind of conditions are needed to help more county parks get ski and snowshoe ready?

"We don't groom until we have about 6 inches of snow," Heller said. "And we need the ground frozen so our equipment doesn't sink through.

When the conditions are right, the county grooms the trails at Nashotah, Menomonee and

Minooka parks. But skiers and snowshoers may use other parts of the parks as well.

"You can ski anywhere you want," Heller said. "A lot of people do use the open area."

Hiking is permitted on winter trails up until they get snow and groomed, according to Heller. After grooming, trails are open

only for skiers. Heller said there are other trails in all parks for hiking and snowshoes.

#### Birkie and more

Next month, Trost noted that the Hayward and Cable area in northern Wisconsin will host the 2023 Slumberland American Birkebeiner between Feb. 22 and 26.

The Birkie event, which bills itself as the largest cross-country ski marathon, spans 50 kilometers from Cable to Hayward for skaters and 55 kilometers for classic

The 2020 event drew skiers from 49 states and 27 countries and it is part of the Worldloppet circuit of over 20 international ski marathons, according to the event website.

If searching out or waiting for good ski conditions is unappealing, there are other indoor and outdoor attractions available during the

winter season, according to Trost. "We have cozy cabins, thrilling water parks, world-class museums," he said.
