# Weyerhaeuser man faces charges in four counties

A 35-year-old Rusk County man remains in the Chippewa County Jail on an unrelated charge pending a plea hearing Sept. 9, 2022, in connection with felony methamphetamine and criminal damage to property charges, Barron County Circuit Court records said.

Defendant Alex L. Hajdasz, formerly of N3799 Sixth St., Weyerhaeuser, appeared via video hookup in a hearing on Friday, Aug. 26, in

A complaint filed in December 2021 alleged that Hajdasz was found hiding in a crawlspace beneath an unoccupied home in the town of

According to court records, Hajdasz is also facing charges in three other Wisconsin counties. They include:

■ Eau Claire County, felony battery, violating a domestic abuse injunction, and bail jumping.

■ Rusk County, burglary and bail ■ Washburn County, felony bail

jumping and misdemeanor battery. Court records show the defendant has also faced felony charges that date back to 2003 in Barron, Rusk, Washburn, Dunn, Chippewa, Eau

Claire and Polk counties.

#### Chetek woman facing multiple drug, related charges

Felony methamphetamine-related charges have been filed in Barron and Rusk counties against a 38-yearold Chetek resident, according to court records.

Defendant Brittany A. Turgeson was charged Sept. 3, 2021, after she was allegedly found in possession of more than 22 grams of methamphetamine during the search of a rural Chetek home.

During an Aug. 19 court hearing at Barron, a trial date was set for Nov.

Rusk County Circuit Court records said Turgeson is also facing four felony meth and/or marijuana related charges. Her latest appearance was Aug. 11, 2022, and the case is scheduled for a review hearing on Oct. 11.


