Woman suffers from Kasch scratch fever

A Holcombe woman has been charged in Rusk County Circuit Court after a report that she was possibly on drugs and paranoid.

Krystl A. Kasch, 41, has been charged with one misdemeanor count of disorderly conduct with the modifiers of domestic abuse and domestic abuse assessments. If convicted, Kasch could be sentenced to a maximum of 90 days incarceration or \$1,100 in fines or both

Kasch appeared in Rusk County Circuit Court on Sept. 22 for a bond hearing. Her \$1,000 signature bond was modified to allow non-abusive contact with the caller.

According to the criminal complaint, on March 27 a Rusk County deputy was dispatched to a Township of Washington residence for a domestic disturbance. The caller reported that Kasch was possibly on drugs and acting very paranoid and had scratched the caller.

Upon the deputy's arrival, Kasch

said she had been in an argument with the caller and ended up pushing the caller away from her. Kasch said she believed someone had tampered with her mail.

Kasch allegedly believes the caller is trying to make her feel like she is

The caller told the deputy that the argument began earlier that morning when Kasch accused the caller of putting Vaseline on her clothes. The caller laughed at the accusation and Kasch allegedly grabbed the caller by the neck and shoved the caller, according to the criminal complaint.

The argument had taken place upstairs in the home and when she pushed the caller, the caller instantly told Kasch that law enforcement would be called. When asked to move out of her way, Kasch said the caller laughed in her face.

Kasch is scheduled to appear in Rusk County Circuit Court on Oct. 10 for an initial appearance hearing.

Vehicle plunges in lake, Exeland man found dead

The Barron County Sheriff's Department received a call at 8:35 p.m., Friday, Sept. 30, of a truck in the water on Red Cedar Lake just off Hwy 48, north of Mikana.

Deputies from the Barron County Sheriff's Department along with the Birchwood Fire Department, Birchwood Ambulance, Chetek Fire Department Dive Team and Wisconsin Department of Natural Resources responded.

An initial investigation shows a truck driven by Christopher Kemmits, 30 of Exeland, was travelling east on County V, according to Barron County Sheriff Chris Fitzgerald. Kemmits failed to stop for the stop

sign at the intersection of County V and 48 and went into the lake.

"It appears that Mr. Kemmits was able to get out of the vehicle but could not make it to shore," Fitzger-

The Chetek Fire Department Dive team was able to locate Kemmits in the water, and he was brought to shore where he was pronounced dead, according to Fitzgerald.

The cause of the crash remains under investigation by the Barron County Sheriff's Department and the Barron County Medical Examiner.

Fitzgerald thanked the neighbors in the area who immediately provided boats as rescuers arrived.

Revised grant awards a plus for ambulance service

Service was awarded \$86,665. This is slightly more than the award originally released by the state.

State officials made a calculation error and revised it with higher numbers for multiple ambulance services. For Rusk County Ambulance Service, this revision resulted in \$3,345 in additional grant funds.

Originally, state officials announced an \$83,320 award for the Rusk County Ambulance Service.

County officials had applied for more than \$200,000 during the grant application process, according to Emergency Services Coordinator Tom Hall.

"There were five categories we could apply in, and the total awarded is divided between three of them," Hall said.

The funding for Rusk County

The Rusk County Ambulance breaks down to \$42,285 for equipment and \$8,740 for training. Another \$35,640 will go toward assistance with the new ambulance

"It is a good award we are getting. It will help us with buying some equipment and doing some training," Hall said.

The training will be used to train 10 additional staff to the Advanced EMT level. The equipment portion will be used for updating a cot and purchasing a fifth Lucas Device. The balance will go to helping with the purchase of a new ambulance.

Payment will be in two parts, with half to start with orders and the other half when the purchases are completed.

"As with most grants the money cannot be used to supplant funds al-

ready budgeted for use," Hall said.
