## Thefts alleged at Walmart as suspects ditch girlfriend at Ladysmith store

Two suspects are facing charges of retail theft after they allegedly stole from the Ladysmith Walmart on Sunday, July 2.

Shawn N. Lau, 41, and Sarah B. Oelbaum, 38, both of Eau Claire have been charged with retail theft – intentionally taking \$500 - \$5,000.

According to the criminal complaint, officers responded to the Ladysmith Walmart for an active merchandise "roll out," in which two male suspects, one identified later as Shawn N. Lau, had left the store with two cart loads of unpaid merchandise. A third suspect, later identified as Sarah B. Oelbaum, was left at the scene.

Oelbaum was asked about the backpack she had left in the parking lot, also full of unpaid merchandise. The criminal complaint shows that Oelbaum admitted to pulling the fire alarm and leaving the backpack after she realized she had been ditched by her co-conspir-

Video surveillance shows Lau and the other male suspect leaving the store with two carts full of products. They were able to load one cart's worth of goods into their car before police arrived, before panicking and leaving both Oelbaum and the other cart behind.

According to Walmart employees, the items left behind included a crossbow and a 12-pack of Twisted Tea. Including the items recovered from Oelbaum's backpack, the total value of merchandise that passed the point of purchase and exited the building without being paid for is \$1,572.96. The value of the unrecovered items is unknown

at this time. The criminal complaint alleges that while officers were arresting Oelbaum, Lau contacted Walmart to ask about the whereabouts of his girlfriend. Officers were then able to contact Lau on the phone where he apologized for the whole thing. Officers advised that Lau return to Ladysmith with the stolen merchandise. According to the complaint Lau then stated, "I will do that, I will. I want to do it for Sarah," and told officers he would return before 7 a.m.

As of the time of publication, it is not known if Lau has turned himself in as promised or not.

A cash bond of \$1,000 was set for Oelbaum. An initial court appearance was set for July 11.

## Past Weyerhaeuser mail carrier sentenced

A former Weyerhaeuser mail carrier who was originally charged with a methamphetamine dis-

tribution offense nearly three and one-half ago was sentenced to two years' probation Wednesday, June 28, in Barron Circuit **Timothy** Court.

In a deal with prosecutors, former Chetek resident Timothy D. Wilson, 69, now living in Chippewa Falls, pleaded guilty to a reduced felony charge of methamphetamine possession, in exchange for dismissal of two other charges.

Conditions of Wilson's probation require him to remain absolutely sober and to work with his probation agent to complete any and all evaluations, counseling, treatment and

He cannot possess or consume controlled substances, unless prescribed, and "must not associate with anyone known to have or be using controlled substances, except in a controlled setting," court records added.

Wilson was originally charged with possession between 10 and 50 grams of meth with intent to sell after his arrest while he was on his mail delivery route near Weyerhaeuser Monday, Feb. 10, 2020.

Earlier the same day, Barron County Sheriff's investigators executed a search warrant at the defendant's home in Chetek. No one was there at the time. But investigators seized unused plastic bags, a digital scale covered with alleged meth residue, smoking devices, and a sandwich bag containing more than 20 grams of

When he was taken into custody in Rusk County, the defendant was allegedly found in possession of more meth and \$929 in cash, mostly in the form of \$20 bills, the complaint said.

## Cornell man faces OWI charge in Brill crash

An Aug. 1, 2023, preliminary hearing is set for a Chippewa County man charged with felony drunk driving after he crashed just outside the village of Brill on Memorial Day Weekend, according to a complaint filed July 5 2023, in Barron County Circuit Court.

The defendant, Matthew A. O'Donnell, 37, Cornell, could face up to a six-year prison term in connection with the charge, court records added.

The crash was reported just before 5 p.m. May 28, at the corner of County Hwy. V and 23 ½ Street. A state trooper responded to a 911

call about a vehicle that had struck a bridge.

The trooper arrived to find a van on the highway next to a guard rail on a bridge over the Brill River. The driver, later identified as the defendant, was moaning but otherwise not responsive.

The trooper said he was helping medical personnel with the driver when he saw a crushed beer can in the cupholder under the radio.

There was a 12-pack of beer on the floor between the front seats.

The driver smelled of alcohol. After the driver was flown to Mayo Hospital in Eau Claire, two

troopers helped to get a blood sample for a chemical test. The sample was later returned with a reading of .286, more than three times the state's legal limit of intoxication.

Records show O'Donnell has three prior convictions for OWI dating back to 2005.

The complaint also includes traffic citations for failure to keep a vehicle under control, failure to transfer a vehicle title, operating a vehicle without insurance, and failure to wear a seatbelt.

Court records said the defendant is free on \$2,500 signature bond pending further action.

The May 2022 criminal complaint said Bohannon already had four drunk driving convictions on his record when a Rice Lake officer allegedly saw him ride a motorcycle through a stop sign on May 8, 2022.

Court records said Bohannon faces up to to 10 years in prison and/or a \$25,000 fine when he is sentenced
