# Former Norwalk man pleads no contest to sexual assault

Appearing in Monroe County Circuit Court, a former Norwalk man pleaded no contest in April to first-degree sexual assault of a child younger than 13.

Joshua Perrigo, 30, whose most recent address was in Green Lake, Wis., received a 24-month diversion for the felony count. The incident occurred in Norwalk on or between June 1, 2018, and Nov. 1, 2018, according to the criminal complaint. The child was 7 at the time. The incident was reported in November 2018.

Perrigo has a review hearing scheduled for Aug. 8.

The Monroe County Sheriff's Office and Chief David Jones of the Norwalk Police Department investigated the case.


According to online court records, Perrigo also is facing multiple charges of bailing jumping, disorderly conduct, battery, possession of THC, and strangulating and suffocation in Monroe County, and bailing jumping, disorderly conduct, and strangulation and suffocation in Juneau County. All of those cases remain open.

In 2017, Perrigo pleaded no contest to possession of THC (second offense), bail jumping and disorderly conduct (domestic abuse). In 2016, he was found guilty of bail jumping (misdemeanor), possession of THC, and possession of drug paraphernalia.

He pleaded no contest to bail jumping (misdemeanor) and operating vehicle without concest of passenger in 2013.

Also, in 2011, he pleaded no contest to resisting or obstructing an officer and theft – movable property (less than or equal to \$2,500.

# Monroe County hoping for nearly \$1M federal appropriation for landfill expansion

Monroe County Administrator Tina Osterberg told county supervisors last week a \$952,000 Congressional appropriation request to help cover an expansion project at the Ridgeville Landfill has cleared its first hurdle.

Osterberg made her remarks at the Monroe County Board meeting April 26, saying Sen. Tammy Baldwin is advancing the request to the senate appropriation committee, of which she is a member.

If the committee approves the

appropriation, the funds will still have to become part of the 2024 federal budget and survive any attempts to scrap them. Baldwin succeeded in garnering a similar \$250,000 appropriation for the Sparta Library expansion project a few years back.

The county requested its funds in an effort to address an unanticipated financial setback for the landfill expansion due to new DNR regulations. According to David Heser, the county solid waste manager, the county had to deposit over \$1 million into an account to fully fund its liability insurance, a new requirement

of the DNR. That money was previously earmarked for a new waste cell at the landfill.


The county also is dealing with an accelerated timeline for the land-fill expansion project triggered by an increased waste stream from Fort McCoy during the time the military installation hosted several thousand Afghan refugees.

Heser said if the county is denied the federal funding, it will fall back on bonding the money, and the loan payoff will be reflected in a relatively minor increase in tipping fees at the landfill over the next two decades. The tipping fee, which is the cost per ton of waste paid by haulers who dump in the landfill, is the sole funding for the landfill operation. It is projected to rise from its current \$57 per ton to \$72 per ton in 2041 if no federal assistance is forthcoming. That would drop to \$70 per ton by 2041 if the county receives the appropriation. Still, the Ridgeville Landfill has the lowest tipping fee in the area.

The current waste cell is projected to be full by June 2025. The county plans to begin construction

Notice is hereby given that the Board of Review for the Town of Wilton, Monroe County, Wisconsin, shall hold its first meeting on June 1, 2023 from 5:00 p.m.to 7:00 p.m., at the Town of Wilton town hall. Please be advised of the following requirements to appear before the board of review and procedural requirements if appearing before the board:

- 1. No person will be allowed to appear before the board of review, to testify to the board by telephone, or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the assessor to enter onto property to conduct an exterior view such property being assessed.
- 2. After the first meeting of the board of review and before the board's final adjournment, no person who is scheduled to appear before the board of review may contact or provide information to a member of the board about the person's objection, except at a session of the board.
- 3. The board of review may not hear an objection to the amount or valuation of property unless, at least 48 hours before the board's first scheduled meeting, the objector provides to the board's clerk written or oral notice of an intent to file an objection, except that upon a showing of good cause and the submission of a written objection, the board shall waive that requirement during the first 2 hours of the board's first scheduled meeting, and the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days with proof of extraordinary circumstances for failure to meet the 48-hour notice requirement and failure to appear before the board of review during the first 2 hours of the first scheduled meeting.
- 4. Objections to the amount or valuation of property shall first be made in writing and filed with the clerk of the board of review within the first 2 hours of the board's first scheduled meeting, except that, upon evidence of extraordinary circumstances, the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days. The board may require objections to the amount or valuation of property to be submitted on forms approved by the Department of Revenue, and the board shall require that any forms include stated valuations of the property in question. Persons who own land and improvements to that land may object to the aggregate valuation of that land and improvements to that land, but no person who owns land and improvements to that land may object only to the valuation of that land or only to the valuation of improvements to that land. No person may be allowed in any action or proceedings to question the amount or valuation of property unless the written objection has been filed and that person in good faith presented evidence to the board in support of the objections and made full disclosure before the board, under oath, of all of that person's property liable to assessment in the district and the value of that property. The requirement that objections be in writing may be waived by express action of the board.
- 5. When appearing before the board of review, the objecting person shall specify in writing the person's estimate of the value of the land and of the improvements that are the subject of the person's objection and specify the information that the person used to arrive at that estimate.
- 6. No person may appear before the board of review, testify to the board by telephone, or object to a valuation if that valuation was made by the assessor or the objector using the income method of valuation, unless the person supplies the assessor with all the information about income and expenses, as specified in the assessor's manual under s. 73.03 (2a), Wis. stats., that the assessor requests. The Town of Wilton has an ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph that provides exceptions for persons using information in the discharge of duties imposed by law or the duties of their officer or by order of a court.\* The information that is provided under this paragraph, unless a court determined that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35 (1), Wis. stats.
- 7. The board shall hear upon oath, by telephone, all ill or disabled persons who present to the board a letter from a physician, surgeon, or osteopath that confirms their illness or disability. No other persons may testify by telephone unless the Board, in its discretion, has determined to grant a property owner's or their representative's request to testify under oath by telephone or written statement.
- 8. No person may appear before the board of review, testify to the board by telephone, or contest the amount of any assessment unless, at least 48 hours before the first meeting of the board, or at least 48 hours before the objection is heard if the objection is allowed under s.70.47 (3) (a), Wis. stats., that person provides to the clerk of the board of review notice as to whether the person will ask for the removal of a member of the board of review and, if so, which member, and provides a reasonable estimate of the length of time the hearing will take.

of its new cell next spring. That three-acre expansion is expected to last four years. Subsequent expansions of the current site should carry the operation into 2041.

After that, there are still areas on the 240-acre tract where new waste cells can be constructed, according to Heser.

In other business, the county board approved several resolutions, including:

- Approving the use of \$2,200 of Conservation Reserve Enhancement Program (CREP) funds for trees planted near the new Rolling Hills Senior Living Center.
- Increasing the Aging and Disability Resource Center (ADRC) driver position to part time.
- Approving a statewide mutual aid compact for local emergency management assistance.

NOTICE IS HEREBY GIVEN that the Board of Review for the Village of Ontario, Vernon County, Wisconsin, shall hold the Board of Review on July 26, 2023, from 6-8pm, at Village Office-205 State Street.

Please be advised of the following requirements to appear before the board of review and procedural requirements if appearing before the board:

- 1. No person will be allowed to appear before the board of review, to testify to the board by telephone, or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the assessor to view the property.
- 2. After the first meeting of the board of review and before the board's final adjournment, no person who is scheduled to appear before the board of review may contact or provide information to a member of the board about the person's objection, except at a session of the board.
- 3. The board of review may not hear an objection to the amount or valuation of property unless, at least 48 hours before the board's first scheduled meeting, the objector provides to the board's clerk written or oral notice of an intent to file an objection, except that upon a showing of good cause and the submission of a written objection, the board shall waive that requirement during the first 2 hours of the board's first scheduled meeting, and the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days with proof of extraordinary circumstances for failure to meet the 48-hour notice requirement and failure to appear before the board of review during the first 2 hours of the first scheduled meeting.
- 4. Objections to the amount or valuation of property shall first be made in writing and filed with the clerk of the board of review within the first 2 hours of the board's first scheduled meeting, except that, upon evidence of extraordinary circumstances, the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days. The board may require objections to the amount or valuation of property to be submitted on forms approved by the Department of Revenue, and the board shall require that any forms include stated valuations of the property in question. Persons who own land and improvements to that land may object to the aggregate valuation of that land and improvements to that land, but no person who owns land and improvements to that land may object only to the valuation of that land or only to the valuation of improvements to that land. No person may be allowed in any action or proceedings to question the amount or valuation of property unless the written objection has been filed and that person in good faith presented evidence to the board in support of the objections and made full disclosure before the board, under oath, of all of that person's property liable to assessment in the district and the value of that property. The requirement that objections be in writing may be waived by express action of the board.
- 5. When appearing before the board of review, the objecting person shall specify in writing the person's estimate of the value of the land and of the improvements that are the subject of the person's objection and specify the information that the person used to arrive at that estimate.
- 6. No person may appear before the board of review, testify to the board by telephone, or object to a valuation if that valuation was made by the assessor or the objector using the income method of valuation, unless the person supplies the assessor with all the information about income and expenses, as specified in the assessor's manual under s. 73.03 (2a), Wis. stats., that the assessor requests. The Village of Ontario has an ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph that provides exceptions for persons using information in the discharge of duties imposed by law or the duties of their officer or by order of a court.\* The information that is provided under this paragraph, unless a court determined that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35 (1), Wis. stats.
- 7. The board shall hear upon oath, by telephone, all ill or disabled persons who present to the board a letter from a physician, surgeon, or osteopath that confirms their illness or disability. No other persons may testify by telephone unless the Board, in its discretion, has determined to grant a property owner's or their representative's request to testify under oath by telephone or written statement.
- 8. No person may appear before the board of review, testify to the board by telephone, or contest the amount of any assessment unless, at least 48 hours before the first meeting of the board, or at least 48 hours before the objection is heard if the objection is allowed under s.70.47 (3) (a), Wis. stats., that person provides to the clerk of the board of review notice as to whether the person will ask for the removal of a member of the board of review and, if so, which member, and provides a reasonable estimate of the length of time the hearing will take.


## AUGUST "AUGGIE" OAKLEY HANSON



# History program on Camp McCoy slated for May 11

## Contributed by the Monroe County Local History Room

In a diary entry dated Feb. 20, 1942, George Barry of La Fayette Township, writes, "Got a big surprise today. A US Marshal was here and served notice on my wife and 11-year-old daughter [that we] have to be out of here by March 10—eighteen days hence!"

On Thursday, May 11, at 7 p.m., Ryan Howell, Garrison Archaeologist and Historian at Fort McCoy, will present the program "Army Maneuvers: The 1942 Expansion of Camp McCoy and Eminent Domain Farm Removals" at the Monroe County Local History Room & Museum in Sparta.

The program will cover the history of the 1942 expansion of what was then Camp Mc-Coy from the pre-World War II 9,000 acres of "Old South Post" to the modern installation of 60,000 acres. This 1942 51,000-acre base expansion removed a large number of Monroe County farm families from rural communities via eminent domain.

Farm owners were compensated financially but were not given an option to negotiate on price or resist removal.

Period historical documents associated with the farm removals will be on display, and the results of historical and archaeological studies conducted by Fort McCoy on the demolished farmsteads since the 1990s will be discussed and presented as
