Man shot woman in Marinette apartment

MARINETTE-A fatal shooting at a downtown Marinette apartment complex earlier this month has been ruled justified.

"This was a very painstaking process and not one that was arrived at easily. ... It was a very difficult decision because this was a tragic event," Marinette County District Attorney DeShea Morrow said.

Edwina Anderson, 32, died Dec. 1 when she was shot four times by her boyfriend Nicholas Smith, 31, who was in the process of moving in with her, according to Marinette Police Detective Mike Kahles.

Kahles, along with Morrow and two members of the county's Department of Health and Human Services, spoke at a press conference Saturday morning in the common council chambers at Marinette City Hall. Numerous law enforcement, court and county DHSS employees were in attendance.

The shooting took place Dec. 1 at the Trolley Station Terrace Apartments, 1529 Main St. Officers were dispatched to the scene shortly after 4 p.m. for a report of a female with gunshot wounds. A neighbor made that 911 call.

located in the hallway of the apartment. "The female appeared to have gunshot wounds. She also had a knife in her hand," he said, adding that the knife had a red substance on it consistent with blood.

Following emergency life-saving measures, the victim was transported to Aurora Medical Center—Bay Area where she died because of her injuries.

Kahles said a second 911 call later from Smith, who "reported that he had been stabbed and he thought he shot somebody." That call came from another location in

Marinette. He said Smith was transported to the hospital, treated and lodged in jail.

Smith was stabbed in his left hand and he had outpatient surgery, the detective said.

Kahles said the Marinette Police Department, the Marinette County Sheriff's Office, the Wisconsin State Crime Laboratory Crime Scene Response Unit, the Oconto County Sheriff's Office, the Marinette County District Attorney's Office, in consultation with the Department of Justice, all vigorously investigated" this incident.

It was a complex investigation involving all of law enforcement's resources," Kahles said. "Through the course of the investiga-Kahles said the female, Anderson, was tion, including crime scene processing, evidence collection, witness interviews, audio and video recordings, autopsy results and interviews with involved parties, it has been determined that the shooting was justified under Wisconsin law and no charges will be filed at his time."

regarding placement. Kahles said the children were not in the immediate area where the shooting took place. He said they were unharmed and immediately removed from the scene.

Kahles said Smith fired six rounds and Anderson was shot four times—in the right chest, the right rear hip, the upper back left shoulder and the right arm. He said the shot to the upper back shoulder penetrated both lungs and likely was the fatal shot, according to the doctor who did the autopsy. He said they ware still waiting on the final autopsy report.

Kahles said the pistol—a 357 revolver was tucked under the mattress in the bedroom where the incident took place. He said the confrontation started with about 10 to 15 minutes of arguing and then turned physical. He said Anderson went into another room and came back with a knife and she stabbed Smith in his left hand as he was holding the gun in his right hand. He then fired the six shots in less then 10 seconds.

Morrow said Smith warned Anderson to stop as she came into the room with the

STREET TACOS RECIPE (FEEDS 4-6)

2 white onions, chopped (one for frying, one for topping)

3-4 cloves of garlic, minced

2 packs of Sazón (replaces your taco seasoning mix)

Sazonador adobo seasoning, to your liking

1 pound ground beef

1 can Goya black beans (if swapping out the meat for the vegetarian version)

1 package of Supremo Queso Fresco, crumbled

1 package of El Milagro Tortillas

1 bunch of cilantro, chopped

Add oil to a frying pan. Chop one onion and add to the pan. Sprinkle onion with one pack of Sazón. Season with Sazonador adobo seasoning. Fry onion for five minutes or until translucent. Add garlic and fry for one minute.

Add hamburger to the onion and garlic mixture, along with one more packet of Sazón. Brown the hamburger. (Vegetarians can add black beans or pinto beans to replace the hamburger.)

While the hamburger is cooking, dice up the other onion and cilantro. Crumble up the queso fresco. Set aside for toppings.

Pan-fry the tortillas in oil on the stove.

Fill tortillas with meat, onion and cilantro, with queso fresco on top.
