# Arbor Vitae town board talks Oneida County ambulance contract

Bauers: Only two ways to cover rising costs, Vilas County creates own service or seek referendum

The Arbor Vitae town board, at its June 21 meeting, talked about an annual ambulance service contract proposed by Oneida County, which includes an increase in costs for the town from \$110,000 in 2023 to \$227,303 in 2024.

Town chairman Frank Bauers didn't waste anytime when he started the discussion by saying he "didn't like the amount" being proposed.

"Almost double," he said. "And the year before that, we were (around) \$80,000."

Bauers said it never made much sense for the town creating its

### Fifield town board faces buoy backlash Residents call for different ways forward

Though it wasn't on the Fifield town board's June 20 meeting agenda, a few residents took turns at the beginning of the meeting in public comment to voice their frustrations and propose a way forward with regard to illegal buoys placed on Pike and Round lakes.

Even though proper procedure was not followed when adding the additional buoys on behalf of the town, a Price County recreational officer was enforcing the new signage last season.

One boater, Troy Tabbert, shared with *The Lakeland Times* his \$232 citation he received on Aug. 16, 2022.

According to the town board meeting minutes for March 21, recreational warden with the Department of Natural Resources (DNR) Robin Miller told board members six additional buoys placed on the lakes in 2022 were illegal and should have been unenforcable.

And even though town board meeting minutes and others involved with the situation say there were six illegal buoys placed, the Pike Lake Chain Lakes Association claims it was four.

The town hasn't replaced the buoys on the lakes this boating season, but according to the lakes association, it will seek to follow proper and legal procedure this time in order to replace them.

Tom Birchell pointed this out when he was the first to comment on the buoy situation at the June 20 meeting. He read a recent lakes association Facebook post regarding a June 26 listening session for the placement of the buoys.

"It says 'A group of owners who have lakeshore property affected by large waves on our lake association board request the town of Fifield board to reinstall the four buoys purchased by the association," Birchell said while reading the post. "These four buoys were in the water in 2022, but were not put back into the water this spring.' ... I got some problems with this. Birchell expressed frustration as he recapped what happened at the meeting in March. The town board when asked about where the buoys came from, he said, were "lock-jawed" and didn't have any answers at that time. Birchell also took issue with the lakes association saying in its post it purchased the buoys. "Why did it have to come out that way now this far into the game?" he asked. "And again at the March meeting, you (town chairman Bill Felch) made a motion to put the 10 buoys back in that were put in legally ... and now here we are, two months later, we're gonna have another

# with possessing child pornography pleads not guilty

A former fourth-grade math teacher in the Minocqua Hazelhurst Lake Tomahawk (MHLT) school district being charged with two counts of possessing child pornography entered a not guilty plea during an arraignment June 21 in Vilas County circuit court.

Lucas Aschbrenner, 45, was arrested at his home March 2.

Investigators also recovered Aschbrenner's laptop at the time of his arrest, which, according to the results of a subsequent forensic analysis, contained up to eight explicit internet searches related to child pornography and pedophilia and several downloaded images from books

### depicting nude children.

Following his arrest, the state's department of justice issued a press release saying investigators obtained a search warrant based on

abuse material cyber tip originating from Aschbrenner's home.

The forensic analysis also showed, according to the March 6 criminal complaint, Aschbrenner's laptop containing a software used to remove and

The Oneida County sheriff's office investigated a fatal shooting Thursday morning at a Rhinelander area pawn shop.

According to a press release issued by sheriff's captain Tyler Young, a call was received at approximately 11:35 a.m. Thursday reporting a shooting at Hodag Gun and Loan, 2262 Lincoln Street, in the Town of Pelican.

He read a prepared statement recapping the timeline of events and why it's important public officials are held accountable.

Ramker made it clear he opposed adding new buoys and said he likes things the way they are. He also called for those who purchased the buoys, the lakes association, to be fined.

"I don't want to see anything banned, I don't want to see any new buoys put out there," he said. "I've been coming up here my entire life."

Meanwhile, the Price County circuit court decided to reopen Tabbert's case involving the boating violation he received because of one of the illegal buoys.

The first court date since the case has been reopened was June 23, at 11 a.m.


