rooms."

For Verbsky, the use of Airbnb rentals to help supplement the space offered by the Hotel Hillsboro and other local rentals, such as the Blue Highway Lodge, is necessary until another hotel is built.

Another local business owner, Karri Bartlett, took a turn to speak as well. Bartlett owns and operates the Blue Highway Lodge alongside her husband, Nathan Toth. For Bartlett, the biggest concern regarding Airbnb rentals involves just how easy it can be to open one without needing to adhere to any of the regulations a standard hotel or vacation rental service is held to, particularly when it comes to health and safety.

Following the closure of the public comment portion of the meeting, and the public hearing regarding the rezoning of a property located on Hillsborough Avenue to enable the operation of an Airbnb rental, the council voted to approve the rezoning. Alderwoman Elizabeth Parish voted against the rezoning.

Another ordinance was passed following the rezoning, this one focused on establishing guidelines for short-term rentals in the City of Hillsboro. The new ordinance largely takes its wording and requirements from existing state statutes, with some revisions made for the city.

According to the new ordinance, those looking to turn their property into a short-term rental must apply for and receive a permit from the "We need more city in order to do so. Requirements business hours.

for the permit include providing information such as proof of insurance, identification of the owner, and identification and phone number of the residential operator.

Short-term rental properties are expected to adhere to state statutes, and are expected to have functional alarms and carbon monoxide detectors to comply with health and safety guidelines. These properties are also expected to adhere to "quiet hours" established by the city. Here in Hillsboro, these hours begin at 10:00P.M.

Permits may be forfeit if the owner becomes delinquent with regards to taxes or other payments owed to the city. Should a property see three calls for police services in a 12-month period, the council may refuse to renew the property's short-term rental permit.

Among the revisions made to the ordinance were conditions that resident operator must live either in the City of Hillsboro or within 25 miles of the city and that a log of license plates of those renting the property should be maintained in case of an emergency.

The ordinance passed with full council support and goes into effect immediately. There will be no grandfathering in of established shortpreviously term rental properties within the City of Hillsboro; all relevant properties, current and future, will be expected to abide by the new ordinance moving forward.
