## Branen Scholarships

William E. Branen, former publisher of the Burlington Standard Press and a past president of the Wisconsin Newspaper Association, died in 1988, but his legacy lives on through an annual scholarship. The Branen Family Scholarships were established by his wife, Nan, through the family foundation.

Initially awarded to a Burlington High School student, the Branen scholarships took a new focus in 1999. Since that time, the scholarships honor the student publications that earn first place for General Excellence in the Wisconsin Newspaper Association Foundation High School Better Newspaper Contest.

## Editorial

## General Excellence Division A

**First Place**: *Wisconsin State Journal* - **Judge's Comments**: There's a lot to like about this paper, including the special sections it does. The "Our dome, our home" piece was outstanding.

Second Place: The Post-Crescent - Judge's Comments: The front page packages are consistently a great read. I LOVE The Buzz in Business and wouldn't mind stealing the idea.

**Third Place**: *La Crosse Tribune* - **Judge's Comments**: The best in local news. It really digs in and tells you what you need to know if you live here.

Honorable Mention: Leader-Telegram - Judge's Comments: Some very strong front pages (with great news stories); the inside content should be less wire-dependent.

#### **Division B**

First Place: The Freeman - Judge's **Comments**: This is definitely a photographer's newspaper - great photo play, diversity of shots. Layout is a little dated but the content is what earned The Freeman a win. On the day of a search for an autistic child, the ME wrote a live editorial in response. Impactful reporting, layout and photography on the same incident. Good story mix. Headline writing needs some training, but overall this is a great community paper. It's deeply local with a very robust report. Readers will spend a lot of time with each edition and I imagine the community feels very connected to its paper.

Second Place: The Gazette - Judge's Comments: The highlight of The Gazette is its strong, local Opinion page, with solid, pointed editorials and good reader engagement in the letters. It feels like a real forum for ideas. There is a great sense of place in the writing. Stories are tightly edited for space, especially syndicated content. Design is organized, but starting to be dated. Features pages relied on wire/syndicates.

Third Place: The Reporter - Judge's Comments: The Reporter makes great use of its resources. Local report leans heavy on crime news, but front pages are dynamic. Photography is creative and writing is strong. Strong ad showing. Greatest weakness is the Opinion page, which feels generic.

#### **Division C**

First Place: Portage Daily Register

- Judge's Comments: Big events lend themselves to big stories, and the Cambria explosion offered that opportunity. There were missed chances to do more, particularly visually and with the layout, but overall, this entry was the most consistent. 62 points.

Second Place: Daily Citizen - Judge's Comments: Just behind the winner in two of the most important categories (writing and photography), but led the entries in sports and advertising. 59 points.

Third Place: *Baraboo News Republic*- Judge's Comments: Slightly behind the two leaders in photo/art, sports and features - in productivity and quality. Writing was on pace with the two leaders. 58 points.

Honorable Mention: Watertown Daily Times - Judge's Comments: Lacked engaging, modern layout and design, which overshadowed an impressive amount of local information. Reliance on wire stories, instead of local content, limited entry's impact. Best in reproduction. 55 points.

Judge's Comments: This was really close to getting first place. A really incredible deep dive into Frank Lloyd Wright that goes beyond the state boundaries and beyond a story about him.

Third Place: Leader-Telegram, "Buckshot the Magazine" - Joe Ziemer, Nick Erickson, Jason Cox & Marisa Wojcik. Judge's Comments: This is an impressive amount of work - especially considering it comes out monthly. A favorite with readers, I'm sure.

Honorable Mention: *The Post-Crescent*, "History Makers" - Mike Sherry & Ricardo Arguello. Judge's Comments: Clearly this was big news for the local paper. It's hard to compete in this category with special sections that are built entirely around new content when this is a lot of recycled stats and photos. Still, nice job.

First Place: The Gazette, "Compass: Rock County 2017 Consumer Guide" - Staff. Judge's Comments: Clearly a lot of thought was put into this special section - and it's a nice blend of news and advertising content. Full of information that residents need.

**Second Place**: *Beloit Daily News*, "Nature at the Confluence" - Staff. **Judge's Comments**: A nice, in-depth look at what seems like a really interesting place. Nice layout and very informative with pictures, maps and informative pull-out boxes.

# Rekindle nation's unity and resolve

OUR VIEW: America pulled together, helped save the world after Pearl Harbor attack 75 years ago

ay McCool of Madison keeps a piece of shrapnel on his desk at his East Side home. It reminds him of his family's service to their country during World War II, and of America's unity and resolve following the bombing of Pearl Harbor 75 years ago today.

"We had someone destroying the world," McCool recalled this week. "We saw



it in the news. And people became firmly committed." "I wonder,

"I wonder, are we ready to go again?" McCool conThey left the show and soon learned the magnitude of death and destruction in Hawaii. America was entering another world war. McCool's oldest brother,

McCool's oldest brother, Roland, immediately enlisted. Ray McCool, 11 at the time, remembers crying with his mother as they watched Roland walk to the bus stop, bound for service overseas.

"We didn't know what was going to happen," McCool said. "Those are memories that just stay with you. You don't ever erase them."

Roland McCool repaired radio equipment for B-17 bombers. Ray McCool's other brother, Ralph, the

Headlines were above average — lots of compelling words used. Captions were above average.

- Staff. Judge's Comments: The writing
was top notch. The "Killin' It" and
"Remembering Coach Al" stories were
compelling reads. Not a lot of photos but
strong images. The design was strong. I
especially likes the design on the "Cubs"
story. Good use of columnists to add

headlines. Captions were OK.

Honorable Mention: Lake Country Reporter - JR Radcliffe, Evan Frank, Chuck Delsman & Andrew Gruman. Judge's Comments: This entry has strong writing but some tighter proofreading was needed. Photos were few but strong. The design was strong; good use of graphics in lead stories on front pages. The variety of sports covered was OK. The headlines were OK, as were the captions.

Honorable Mention: New Richmond News, "Sunday's storm causes damage across New Richmond area" - Jordan Willi. Judge's Comments: I loved the quotes from a variety of victims. A lot of work in just four days to publication.

Judge's Comments: Really well done - this story covers all aspects of the problem, not just the overdose death. There is a wealth of information for the reader here, presented in a logical, readable format. At the same time, you presented the overdose victim as a real person, with a real problem.

Independent & The Kickapoo Scout, "Flash
flooding in the Kickapoo Valley" - Charley
Preusser & Emily Schendel. Judge's
Comments: Shendel's writing was very
compelling. I felt like I'd been dumped in
the river myself along with her rescuer.

but Storm pounds area had a few too
many overused phrases (you could see it

Reporter did a good job explaining the impact and did a great job at getting voices to talk about the story. Nice job!

Second Place: The Journal Times, "Not so decriminalized with a look at the numbers (sidebar); How pot is prosecuted" - Cara Spoto. Judge's Comments: Very interesting topic and good explanatory reporting. Would have liked to see more with the data analysis and to understand how many charges ended up in plea deals, how many ended up with the alternative class, etc. Good detail in the reporting overall.

Third Place: USA TODAY NETWORK-Wisconsin, "Thousands of rape kits still not tested" - Keegan Kyle & Doug Schneider. Judge's Comments: Solid reporting, but very focused on the official level. Would have liked to see some additional efforts to personalize the story with victims and others who may be waiting on tests. Expanding that voice would have helped advance the story and help it evolve from a political storyline.



First Place: Green Bay Press-Gazette, "Neighbor against neighbor" - Paul Srubas. Judge's Comments: Good packaged summary of the people and the issue related to the potential mine. The linear style worked for the sidebar, but the mainbar could have benefited from another scene or tie-in to the Ogden Club.

Second Place: Wausau Daily Herald, "Granite Peak draws water with little oversight" - Laura Schulte. Judge's Comments: With the owner's tie to the troubled Minnesota resort, this is an interesting and important story for Wisconsin. Two things kept this entry out of the top spot: a couple of typos; and no reaction/comment/no-comment from the resort.

Third Place: The Capital Times, "Tapped Out" - Katelyn Ferral. Judge's Comments: Few of our readers know the depths of the bureaucratic sinkhole that is the Army Corps of Engineers, but this story gives Madison readers a good overview. The lede wasn't as strong as the other placewinners, but there are gobs of good quotes and detail. The story could also have used some of the Army/Corps bureaucratic context to help readers know that the Engineers don't just hate Wisconsin; they hate everyone.

Honorable Mention: *Green Bay Press-Gazette*, "Ledgeview residents say manure pit idea stinks; Ledgeview residents wait for manure answers; Ledgeview farm hopes to increase manure storage" - Doug Schneider. **Judge's Comments**: CAFOs are an emerging problem for urban areas in the Midwest, and one that requires delicate reporting to be fair. While the issue from the view of the neighborhood is clear, a clearer picture of the livelihood of those in ag in the area is missing. Even if it's not the farmer at the center of the issue, a tour of a nearby farm/CAFO would have been an excellent addition.

First Place: Daily Tribune, "It's a Girl's Hunting Life" - Jonathan Anderson & Karen Madden. Judge's Comments: This was head and shoulders over the competition in this category — the reporter painstakingly followed this process from beginning to end, providing a complete picture of readers.




